NATURE OF WORK

This position is charged with supervising sports activities for kids; helping with overall park maintenance and general Recreation Park functions. Receives direction from the Director/Assistant, exercise safety, and follow the policies and procedures of the Alva Recreation Complex

ESSENTIAL JOB FUNCTIONS

1. Responsible for mowing and weed eating park under the supervision of full-time staff.
2. Keeping trash picked up around ball fields and parking lot area.
3. Working nights and weekends inside or outside in concession/supervising activities scheduled
4. Cleaning up building after tournaments
5. Reports directly to the Recreation Director or Assistant with any problems that arise from day to day operations
6. Performs other work as required or assigned.

PHYSICAL/MENTAL REQUIREMENTS

ENVIRONMENTAL CONDITIONS AND SAFETY CONCERNS

Major physical inconvenience or discomfort routinely present in the work situation. About 50 – 60% of the time the incumbent is outdoors. Job requires the incumbent to be aware of and observe safe working procedures. Such hazards that are encountered include but are not limited to glass and sharp objects, diseases, hepatitis, hazardous materials, snakes, animals, poison ivy, and other obstacles.
